AGREEMENT

This Agreement ("AGREEMENT") is made and entered into on August 31, 2022 by and between The i-Care Foundation (ICFP), F-192/1 Block 5, Kehkashan, Clifton, Karachi, Pakistan, and Neurology Research & Patient Welfare Fund (NRPWF), Rafiqi H J Road, Karachi Pakistan.

Whereas, iCFP is a registered Trust, in Pakistan, having a legal Tax Exempt Certificate from the Government of Pakistan and maintains Donor Advised Funds (DAFs) which facilitates philanthropists, charities, government and aid agencies in giving their donations to certain charitable organizations of their choice on iCFP's approved charity list; and

Whereas, NRPWF is a Not-for-Profit organization registered under the 1882 Trust Act, in Pakistan, having a legal Tax Exempt Certificate from the Government of Pakistan; and

Whereas, at the time of signing of this agreement the Chairperson of the Board of i-Care has authorized the management to enter into this Agreement with NRPWF as given in the Fund Utilization Plan. The Fund Utilization Plan or its mutually agreed iterations will become part of this Agreement and modifications in the Fund Utilization Plan will automatically become part of this Agreement, and therefore, in consideration of the various covenants, promises, and conditions set forth below, and intending to be legally bound, the parties hereto agree as follows:

I. PROCESSING OF DONATIONS IN THE US BY ICFA FOR DONORS THAT ADVISE THAT THEIR DONATIONS ARE TO BE DISBURSED TO NRPWF

1.1. NRPWF shall be responsible for:

- a) coordinating with donors interested in contributing funds for the funded projects.
- b) arranging collection of and forwarding donors' checks and/or remittance for approval and deposit in the iCFA account in Boston, MA, United States of America.
- c) NRPWF and/or its representatives must advise iCFP by an email and/or a letter within two weeks of deposit/remittance about the transaction and provide a filled donor advisory form listing the donor details and that the moneys are intended for the funded projects.
- d) making best effort to check that donors or recipients of funded projects (whether individuals or entities) do not (i) appear in the master list of the Specially Designated Nationals and Blocked

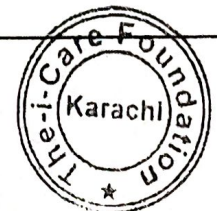
Persons, which list is maintained by the US Treasury's Office of Foreign Assets Control (OFAC) and is available online at OFAC's website: www.gov/offices/eotffc/ofac/ssdn/tl1scln.pdf, or (ii) are not included in any supplementary information concerning prohibited individuals or entities that may be provided by iCFP to NRPWF.

e) all the funds disbursed by iCFP, may be spent only for the charitable purpose in accordance with the description of the Funded Projects provided to iCFP. Funds provided to NRPWF

are made only for the purposes stated in this Agreement, and it is agreed that these funds will be used only for such purposes.

f) providing interim and end of the year reports indicating how the donations received by NRPWF under this Agreement have been utilized and the overall impact of the funded project as more fully described in this Agreement.

g) providing iCFP with such other reports and information as i-Care may require from time to time.
